

# RECORD OF RESOLUTIONS

Resolution No. 2012-33

A RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF CURT KELLY AS A FULL-TIME POLICE OFFICER AND AFFIRMING THE FINAL APPOINTMENT OF CURT KELLY AS A FULL-TIME OFFICER FOR THE VILLAGE OF MINERVA PARK, OHIO AND DECLARING AN EMERGENCY

WHEREAS, a vacancy existed in the Village of Minerva Park Police Department for a full-time officer after the departure of Sgt. Beach; and

WHEREAS, the Mayor and Council for the Village of Minerva Park wish to place someone in this full-time position, and

WHEREAS, Curt Kelly began currently serving as a part-time Police Officer in the Minerva Park Police Department on September 5, 2011 and as a full-time officer on March 6, 2012, Officer Kelly has the necessary qualifications to fill this position; and

WHEREAS, pursuant to R.C. 737.16, the Mayor appointed Curt Kelly as a full-time Police Officer for the Village of Minerva Park on March 6, 2012, and Council for the Village of Minerva Park now wishes to confirm this appointment; and

WHEREAS, Council for the Village of Minerva Park acknowledge the successful completion of the probationary period set forth in R.C. 737.17 by Curt Kelly on September 6, 2012, the transmittal by the Mayor a record of Curt Kelly's service as a part-time officer and during the probationary period, the Mayor's recommendation to affirm the appointment of Curt Kelly as a Full-Time Officer for the Village of Minerva Park; and

WHEREAS, Council for the Village of Minerva Park desires to concur with the recommendation of the Mayor;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MINERVA PARK, OHIO THAT:

SECTION 1: Pursuant to R.C. 737.16, Council for the Village of Minerva Park hereby confirms the Mayor's appointment of Curt Kelly as a Full-Time Police Officer beginning March 6, 2012 at a rate of \$23.20 per hour for a regular work period of forty (40) hours per week.

SECTION 2: Council hereby concurs with the recommendation of the Mayor to affirm the appointment of Curt Kelly as a Full-Time Officer with the Village of Minerva Park.

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

SECTION 4: All prior legislation, or any parts thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.

SECTION 5: Council declares this to be an emergency measure necessary for the health, safety and welfare of the residents of Minerva Park, such emergency arising out of the immediate need to confirm and affirm the full-time officer position as probation ended on August 24, 2012. Wherefore, this Resolution shall take effect and shall be in force immediately upon passage by Council.


