A RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF MICHAEL D MYERS AS A PART-TIME (AS NEEDED) POLICE OFFICER FOR THE VILLAGE OF MINERVA PARK, OHIO AND DECLARING AN EMERGENCY

WHEREAS, there is a vacancy in the Village of Minerva Park Police Department for a part-time (as needed) officer; and

WHEREAS, the Mayor and Council for the Village of Minerva Park wish to place someone in this part-time (as needed) position, and

WHEREAS, Michael Myers began currently serving as a part-time (as needed) Police Officer in the Minerva Park Police Department on February 11, 2013 and has the necessary qualifications to fill this position; and

WHEREAS, pursuant to R.C. 737.16, the Mayor appointed Michael D Myers as a part-time (as needed) Police Officer for the Village of Minerva Park on February 11, 2013, and Council for the Village of Minerva Park now wishes to confirm this appointment.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MINERVA PARK, OHIO THAT:

- Pursuant to R.C. 737.16, Council for the Village of Minerva Park hereby SECTION 1: confirms the Mayor's appointment of Michael D Myers as a Part-Time (as needed) Police Officer beginning February 11, 2013 at a rate of \$19.38 per hour for a work period of up to thirty six (36) hours per week.
- Pursuant to R.C. 737.17, this appointment and confirmation shall be for a SECTION 2: probationary period of six months' consecutive service, and shall not be finally made until Michael D Myers has satisfactorily served his probationary period and the Mayor, with the concurrence of Council, have finally appointed Michael D Myers.
- SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.
- **SECTION 4:** All prior legislation, or any parts thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.
- **SECTION 5:** Council declares this to be an emergency measure necessary for the health, safety and welfare of the residents of Minerva Park, such emergency arising out of the immediate need to fill the part-time (as needed) officer position. Wherefore, this Resolution shall take effect and shall be in force immediately upon passage by Council
