Resolution 2014-14

A RESOLUTION AMENDING THE FEE SCHEDULE OF THE VILLAGE OF MINERVA PARK AND DECLARING AN EMERGENCY

WHEREAS, there is a need to revise fees periodically to stay current with commonly-accepted charges and maintain the fiscal health of the Village and;

WHEREAS, the Village desires to consolidate and update fees into a comprehensive fee schedule;

NOW, THEREFORE, be it resolved by the Council of the Village of Minerva Park, Franklin County, State of Ohio, that:

- Section 1. The Council of Minerva Park hereby amends and revises the fee schedule of various Village services and fees. The revised Minerva Park Fee Schedule is attached and is made a part hereof as if fully rewritten herein.
- Section 2. The Village Mayor, Fiscal Officer, and Law Director are authorized to take further actions consistent with this resolution that are needed to carry out the intentions establishing and adopting a fee schedule for the Village of Minerva Park.
- Section 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.
- Section 4. All prior legislation, or any parts thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.
- Section 5. Council declares this to be an emergency measure necessary for the health, safety and welfare of the residents of Minerva Park, such emergency arising out of the immediate need to revise the fee schedule to allow for new development fees. Wherefore, this Resolution shall take effect and shall be in force immediately upon passage by Council.
