

Resolution 2015-03 Internet Auction

A RESOLUTION AUTHORIZING THE SALE DURING CALENDAR YEAR 2015 OF MUNICIPALLY OWNED PERSONAL PROPERTY WHICH IS NOT NEEDED FOR PUBLIC USE, OR WHICH IS OBSOLETE OR UNFIT FOR THE USE FOR WHICH IT WAS ACQUIRED BY INTERNET AUCTION, PURSUANT TO OHIO REVISED CODE SECTION 721.15(D)

WHEREAS, this Council is required to adopt a Resolution expressing its intent to sell municipally owned property by internet auction, include a description of how auctions will be conducted, specifying the number of days for bidding, and stating the general terms and conditions of sale; and

WHEREAS, after due diligence, the Village of Minerva Park, Ohio is recommending GovDeals, Inc. at gov.deals.com directly or GovDeals through Franklin County Purchasing Department, as the Village's contracted representative to conduct auctions on its behalf.

NOW, THEREFORE, be it resolved by the Council of the Village of Minerva Park, Franklin County, State of Ohio, that:

- Section 1. That during the calendar year 2015, municipally owned personal property which is not needed for public use, or which is obsolete or unfit for the use of which it was acquired, as determined pursuant to the procedure set forth in Section 133.01 of the Codified Ordinance for the Village of Minerva Park, may be sold at internet auction.
- Section 2. That any said auction sales shall be conducted under the authority and direction of the Mayor or Fiscal Officer.
- Section 3. That any such internet auction sales shall be conducted by GovDeals.com internet auction service, 5907 Carmichael Place, Montgomery, AL 36117, phone (800) 613-0156 or through GovDeals with Franklin County, Purchasing Department, 373 South High Street, 25th Floor, Columbus, Ohio 43215.
- Section 4. The sale shall be conducted pursuant to the rules and regulations promulgated and in effect for GovDeals.com or GovDeals through Franklin County Purchasing Department, on file with the Clerk, and as amended from time to time. The sales fee to be paid by the Village of Minerva Park for such internet auction service shall in no event exceed the amount of seven and one-half (7½ %) per cent of the accepted auction bid.
- Section 5. That in connection with each such contemplated internet auction sale bidding shall remain open for not less than ten (10) days, including Saturdays, Sundays and legal holidays.
- Section 6. That in connection with each such contemplated internet auction sale, the terms of payment shall be cash, payment in full on or before the date of delivery to the successful bidder; further, the successful bidder shall be solely responsible for all acts and expenses associated with the delivery of such item(s) so purchased.
- Section 8. It is hereby found and determined that all formal actions of this Council concerning and related to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the Village of Minerva Park which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.
- Section 9. All prior legislation, or any parts thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.
- Section 10. That this Resolution shall take effect and be in force from and after the earliest period allowed by law.
