

# ORDINANCE 14-2016

## AN ORDINANCE AMENDING THE WAGE AND SALARY RANGES, AND THE NUMBER OF EMPLOYEES AND POSITIONS FOR THE VILLAGE OF MINERVA PARK AND DECLARING AN EMERGENCY

**WHEREAS**, pursuant to Section 731.10, Revised Code, the legislative authority may provide such employees for the village as it determines are needed; and,

**WHEREAS**, pursuant to Section 731.13, Revised Code, the legislative authority of a village shall fix the compensation of all officers, clerks, and employees of the village except as otherwise provided by law; and,

**WHEREAS**, the Village Council has established various positions and salary ranges in Ordinance 27-2015 and Ordinance 09-2016; and,

**WHEREAS**, the Council of the Village of Minerva Park desires to amend the positions and number of employees adding a Village Planner position and setting the pay range.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MINERVA PARK, OHIO, THAT:**

**Section 1.** Ordinance 27-2015, Section 1, relating to the number of employees, position classifications, and related pay ranges of Planning and Zoning shall be amended as follows:



Annual Compensation is presented for information only and is calculated based on 2080 hours for full-time employees and 1500 for part-time employees.
