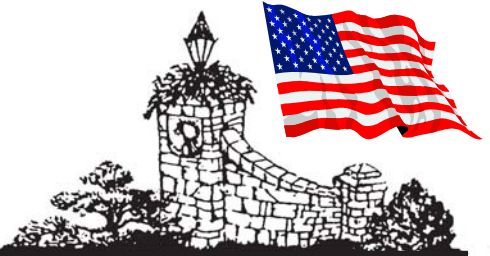

19 members volunteered a total of 373.4 hours for the month, bringing the total for the year-to-date to 1,982.9.

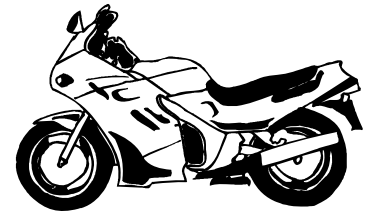

MAYOR'S REPORT

This has been a busy month for meetings. On June 5, Kent Stanley and I attended the Innovative Financing Workshop for Ohio Transportation sponsored by the Mid-Ohio Regional Planning Commission. While most of this meeting was geared toward larger municipalities and projects such as new highways and bridges, there was still quite a bit of good information to be gained.

On June 12 and 13, I attended two days of the 3-day Ohio Mayor's Association Conference, organized by the Ohio Municipal League. This conference provided an excellent opportunity to network with my fellow mayors about many subjects, chief among them the challenges of financing much-needed projects such as street repairs and police and fire protection. The Ohio Department of Natural Resources Division of Forestry gave an excellent presentation about an Emerald Ash Borer Management Plan. We were given a thorough update on pending legislation in both the House and the Senate, and new provisions under the Adam Walsh Act were distributed along with a reference guide for sex offenders and child-victim sentencings. This is a new tier classification that more strictly tracks the offender's movements

(explains the duties to register as a sex offender or child victim offender) and clearly spells out the victim and community notice requirements. Along with Whitehall's Mayor John Wolf, I was appointed to represent District 16 (Fayette, Franklin, Madison, and Pickaway Counties) for the Mayor's Association.

I attended the Regional Income Tax Agency's (RITA) Regional Council of Governments (RCOG) on June 26. It welcomed 15 new members, making RITA 144 members-strong and serving more than 1.4 million residents. You may recall that it was reported to you last year that federal legislation was approved that cleared the way for the IRS to share information with RITA to better enable both agencies to collect delinquent taxes. A formal cooperative agreement between RITA and the IRS was signed September 10, 2007.

Our 2007 tax collections totalled \$235,128. For every \$100 of taxes collected by RITA, only \$3.20 went to the administrative cost of collections, registration, auditing, compliance, record retention, etc., for a total of \$7,527 in administrative costs, leaving a balance of \$227,601 to the Minerva Park General Fund.

Five Council members were present for the regular meeting on June 9. Councilman Todd Walter and Clerk-Treasurer Suzanne Coulter were excused. The following reports were made:

EMS: Chief Rick Hoechstetter reviewed his monthly report. The US Cleaners case has once again been continued to June 11 and will be heard in the Franklin County Environmental Court.

Police:

Chief Bob Hillard reviewed his monthly report. He has ordered DNA and Fingerprinting Kits for the Children's Safety Day scheduled for June 22.

Planning & Zoning - Code

Enforcement: Dick Busick reviewed his monthly report. There are several properties with high grass that are being addressed - the two trucks that are out of character with a residential neighborhood have been removed; and a few more in-home businesses that do not have permits will be contacted. A fence permit application was approved, and an application for a shed will require a variance hearing by the Village Council on July 21.

Minerva Park Community

Association: Councilman Dave Way (MPCA liaison) reported that the Garden Tour is scheduled for June 29 from 1-4, the Garage Sale's date is August 16 from 9-4, Founders Day is July 26, and the Membership Drive will begin in August.

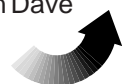
Association: Don Champney reported that the Fourth of July Parade Committee is seeking sponsors, the Beautification Committee is in need of volunteers for judging, there are some concerns about police coverage in the Karl Road area, motorcycle racing on 161 is becoming a real problem, and a Farmers' Market will be opening in Columbus Square on July 8.

Finance: Councilwoman Sharon Bierman received approval for the May warrants totaling \$96,289.94. A Finance Committee meeting will be held on July 2, at 7:00 p.m., at the Community Building.

Legislative: Council President Pam Park-Curry asked the Council to consider the following legislation:

Ordinance 03-2008 - Adopting Chapter 860 of the Minerva Park Codified Ordinances regulating peddlers, solicitors, and canvassers. Third reading. The Council tabled this for further research and discussion.

Resolution 2008-10 - Submitting a tax budget for the expenses and other expenditures of the Village during the fiscal year ending December 31, 2009. Second reading accepted.

Resolution 2008-14 - Authorizing the Mayor and the Clerk-Treasurer to enter into contract for the collection and removal of rubbish, trash, recyclables, garbage, and yard waste from residences. First

reading accepted.

Safety: There was no report.

Service: Councilman Kent Stanley continues to work on a tree inventory project.

Streets: Councilman Jeff Rigg has marked the streets for pothole repairs and crack sealing. Village Engineer Mike Flickinger will be soliciting contractors, and either he or a staff member from his firm will conduct on-site checks during the project. •

Residential Fire

Fire is one of the most common disasters, causing more deaths than any other type of disaster. Fire doesn't have to be deadly if you have early warning from a smoke detector and everyone in your family knows how to escape calmly. Please be serious about the responsibility of planning for and practicing what to do in case of a fire. Here are tips to help you prepare for such an emergency.

Make your home fire safe

Smoke detectors save lives. Install a battery-powered smoke detector outside each sleeping area and on each additional level of your home. Use the test button to check each smoke detector once a month. Replace batteries at least once a year.

Have a working fire extinguisher in the kitchen. Get training from the fire department in how to use it.

Plan your escape routes

Determine at least two ways to escape from every room of your home. If you must use an escape ladder, be sure everyone knows how to use it. Select a location outside your home where everyone would meet after escaping. Practice your escape plan at least twice a year. Once you are out, stay out!

Escape safely

If you see smoke in your first escape route, use your second way out. If you must exit through smoke, crawl low under the smoke to escape. If you are escaping through a closed door, feel the door before opening it. If it is hot, use your second way out. If smoke, heat, or flames block your exit routes, stay in the room with the door closed. Signal for help using a bright-colored cloth at the window. If there is a telephone in the room, call the fire department and tell them where you are.

Chicken (or Turkey) Tetrazzini

1 package (7 oz) thin spaghetti or linguine, broken in half
 2 c cubed cooked chicken or turkey
 1 c sliced fresh mushrooms
 1 small onion, chopped
 3 Tbls butter or margarine
 1 can (10-3/4 oz) condensed cream of mushroom soup, undiluted
 1 c milk
 1/2 tsp poultry seasoning

1/8 tsp ground mustard
 1 c (4 oz) shredded cheddar
 1 c (4 oz) shredded mozzarella
 1 tbls shredded Parmesan
 Minced fresh parsley
 Cook pasta according to package directions. Drain and place in a greased 11x7x2 baking dish. Top with chicken or turkey; set aside.
 In a skillet, saute mushrooms & onion in

butter until tender. Whisk in the soup, milk, poultry seasoning & mustard until blended. Stir in the cheddar; cook & stir over medium heat until the cheese is melted. Pour over chicken or turkey.

Sprinkle with mozzarella & Parmesan (dish will be full). Bake, uncovered, at 350°F for 25-30 min or until heated through & cheese is melted. Sprinkle with parsley.

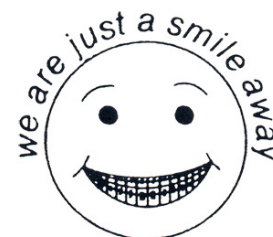
