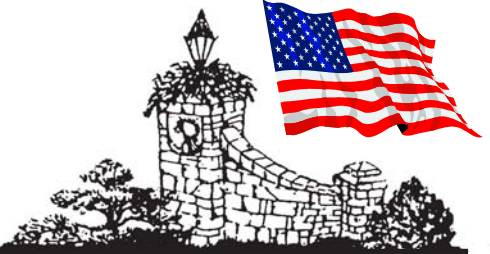

#### Children's Safety Day

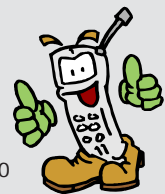

# MAYOR'S REPORT

It's hard to believe how quickly the summer is flying by. I hope it's been a safe and relaxing time for everyone and you've had the opportunity to visit our beautiful pool.

**Recognition:** We have a resident who deserves our thanks and recognition. On June 16, one of our little pool members (a 1½-year-old) was pulled unconscious from the baby pool after his mother and other adult family members summoned help. Shannon Morrison, Wildwood Road resident, pool member, and City of Columbus firefighter, immediately began infant CPR and revived the child, who has recovered and is fine. Had it not been for Shannon, pool lifeguard Nathan Geers, and pool manager John Friedel, we may not have had such a happy ending.

**Power Surges/Outages:** These continue to be a problem. Please keep me informed of time, duration, and the nature of these "electrical occurrences" so we can follow up with our community liaison and the AEP crews. All Council members were present for the regular Council meeting held July 14. The following departmental reports were made:

**Police:** Chief Bob Hillard reviewed his monthly report. Foot patrol is active, Theo Burson will be the newest member of the

police department, and we will be receiving our new radar gun from the State that was awarded to us for the police department's participation in the Click-or-Ticket program last year. Chief Hillard, Sgt. Adam Beach, and Officer Rick West were thanked for their efforts in making the Children's Safety Day, held June 22, such a huge success.

**EMS:** Chief Rick Hoechstetter reviewed his monthly report. Chief Hoechstetter, along with Norm Jones, Tanya Crenshaw, Brad Demeter, and Tony Mazaretti, were thanked for their assistance with the Children's Safety Day.

**Engineer:** Mike Flickinger included his report with the Street Committee report.

**Law Director:** Kerry Boyle had nothing at this time.

**Planning & Zoning/Code Enforcement:** Dick Busick reviewed his monthly report. A shed permit and two fence permits were approved at the July 10 meeting. Zoning was approved for a North Bay resident who had installed two entranceways and partially installed a deck without the proper permits and has been under a stop-work order. Several notices were issued for high grass and weeds, one for an inappropriate truck, and one for an overall improperly maintained property.

**Minerva Park Community Association:** Councilman Dave Way reported that the Garden Tour was very successful; the Annual Garage Sale will be August 16, followed by a Wine & Cheese event at the Pool.

**Northland Community Council:** Don Champney reported that the Shark Bar has been boarded up pending a second hearing in the Franklin County Environmental Court. Northland Area Business representatives have been very vocal in their opposition to this business re-opening as well as any business of the same type. Minerva Park was well represented in

the Northland Fourth of July Parade. The Farmers Market is open on Tuesdays from 4-6 p.m. in the Columbus Square Shopping Center.

The following committee reports were made:

**Community:** Councilman Dave Way reported a very good turn-out (approximately 150 people) for the Children's Safety Day. A Fall Lake Clean-up may be scheduled because of the cancellation of both Spring Lake Clean-ups.

**Finance:** Councilwoman Sharon Bierman received approval of the warrants paid out in June totaling \$159,134.34.

**Legislation:** Council President Pam Park-Curry asked the Council to consider the following legislation:

**Resolution 2008-10 -** Submitting a tax budget for the expenses and other expenditures of the Village. Third reading accepted, passed.

**Resolution 2008-14 -** Authorizing the Mayor and the Clerk-Treasurer to enter into contract for the collection and removal of rubbish, trash, recyclables, garbage and yard waste from Village residences. Second reading accepted.

**Resolution 2008-15 -** Establishing the hourly wages for the Clerk of Courts. Rules suspended, three readings waived, passed as an emergency.

**Resolution 2008-16 -** Supporting a proposed Westerville to Arena District Bikeway. First reading accepted.

A legislative committee meeting was scheduled for July 21.

**Safety:** Councilman Todd Walter had nothing to report.

**Service:** Councilman Kent Stanley had nothing to report.

**Streets:** Councilman Jeff Rigg reported that the Village will hire AJ Asphalt to repair the potholes. •
